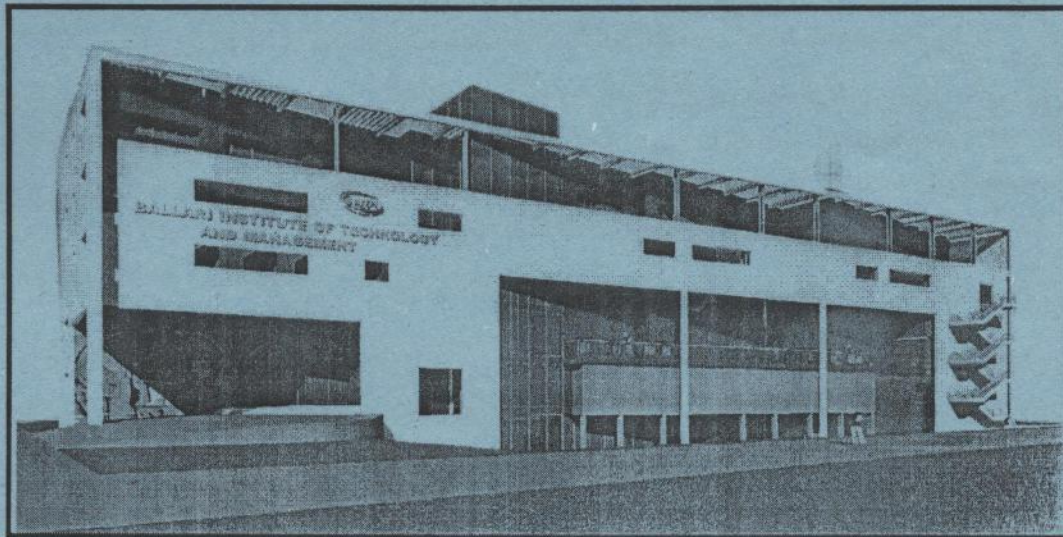

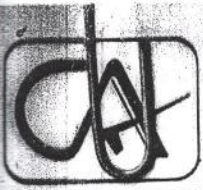

Report on Other Legal and Requirements


