This notice informs all students about a crucial update regarding backlog papers for 2021 scheme subjects/courses (1st to 6th semesters).

As per the Joint Board of Studies' recommendations and approved in the 178th EC meeting, students with backlog papers from the 2021 scheme must appear for exams in the BoS suggested equivalent subjects/courses from the 2022 scheme.

Guidelines for Reading the Equivalence Subject List

- 1. Left side 2021 scheme subjects are listed and against them equivalent courses from 2022 scheme is notified.
- 2. 2022 Scheme Columns: in fe files only subject codes or codes with subject names are listed.
- 3. **No Equivalence**: If "NO MAPPING / NO EQUIVALENCE" is indicated, it means no equivalent subject is available. In this case, students must appear for the exam in the original **2021 scheme subject only**.

#### **Hall Ticket Issuance Requirements**

To obtain a hall ticket, students must submit an UNDERTAKING FORM:

- Duly signed by the student
- Endorsed by the Principal of the Institute
